Dear Ms. Bose:

On December 20, 2019, the Federal Energy Regulatory Commission ("Commission") issued an order in Docket Nos. CP18-46-000 and -001 ("Certificate Order"), authorizing Adelphia Gateway, LLC ("Adelphia") to acquire, construct, and operate certain pipeline facilities and for related authorizations ("Project"). Adelphia filed its Implementation Plan for the Project on February 18, 2020. On October 5, 2020, the Chief of Gas Branch 1 granted Adelphia a partial notice to proceed with construction of Adelphia's Phase 1 Project components, as defined therein. Pursuant to Environmental Condition No. 9 of the Certificate Order, Adelphia hereby requests that the Director of the Office of Energy Projects issue approval to proceed with the construction of the remaining Project facilities by the earliest date practicable, including the (i) Parkway Lateral extending from the Marcus Hook Compressor Station and (ii) segment of the Tilghman Lateral extending from the interconnection with Transcontinental Gas Pipe Line Company, LLC ("Transco Meter Station") to the interconnection with the Monroe Refinery and terminating at an interconnection with the Philadelphia Electric Company ("Phase 2 Project Components").

Adelphia is including herewith the final Erosion and Sediment Control General Permit for Stormwater Discharges Associated with Oil and Gas Activities issued by the Pennsylvania Department of Environmental Protection. All other information required to commence construction of the Phase 2 Project Components was included in Adelphia's Implementation Plan, as supplemented.
