Re: Notice to Proceed with Construction for Phase II Activities and Variance Approval

Dear Ms. Richman:

I grant Adelphia Gateway, LLC's (Adelphia) request to proceed with construction of Phase II activities filed on March 31, 2021. This approval includes the following components, as modified in the request, the Implementation Plan, and supplements:

- Tilghman Lateral from the interconnect to the Transco Meter Station at approximate (MP) 0.4 to its terminus at MP 4.2;¹
- Parkway Lateral;²
- Delmarva Meter Station;³
- Monroe Meter Station;⁴ and
- Tilghman Meter Station.⁵

We also approve Adelpia's variance requests VAR-001, VAR-003, VAR-009a through VAR-009h (filed on January 26, 2021, as supplemented), and VAR-010 (filed on April 5, 2021, as supplemented).

In considering this notice to proceed, we have reviewed your Implementation Plan filed on February 18, 2020, as supplemented on May 11, May 12, June 12, June 30, July 2, August 14, September 4, September 8, September 9, October 1, and October 5, 2020 and January 26, February 18, February 23, March 31, April 1, and May 20, 2021. Based on our review, Adelpia has provided the information necessary to meet the applicable conditions of the Commission's December 20, 2019 *Order Issuing Certificate* (Order) in the above-referenced docket, for those facilities listed above. In addition, we have confirmed the receipt of all federal authorizations relevant to the approved facilities herein.
