The parties submit this joint status report in accordance with the Court's May 21, 2021 order (Doc. 225).

On May 20, 2021, the parties submitted a joint stipulation to stay this case pending the outcome of a pending legal challenge to the prohibition of high volume hydraulic fracturing in the Basin in *Yaw v. DRBC*, No. 2:21-cv-00119-JP (E.D. Pa.). *See* Doc. 225. The Court approved the parties' joint stipulation on May 21, 2021 and ordered the parties to submit a joint status report every six months. *Id*.

The *Yaw* case is currently on appeal to the Court of Appeals from the District Court's orders dated June 11, 2021 and July 2, 2021 granting the Defendants' Motions to Dismiss for lack of standing. *See Yaw v. DRBC*, No. 21-2315 (3d Cir.).

The parties, given the status of the *Yaw* case, respectfully request that the Court continue the stay of this case in accordance with the terms of the May 21, 2021 stipulation and order (Doc. 225).
