FOOD & WATER WATCH PETITION FOR REVIEW

Pursuant to the Natural Gas Act, 15 U.S.C. § 717r(b), the Administrative Procedure Act, 5 U.S.C. § 554, and Rule 15(a) of the Federal Rules of Appellate Procedure, Food & Water Watch (“Petitioner”) hereby petitions this Court for review of final agency actions taken by the Federal Energy Regulatory Commission (“FERC” or “Commission”) granting a certificate authorizing construction and operation of the East 300 Upgrade Project (“Project”) under Section 7 of the Natural Gas Act, 15 U.S.C. § 717f(e). Petitioner seeks review of the orders designated below:

1. *Tennessee Gas Pipeline Company, L.L.C.*, FERC Docket No. CP20-493-000, Order Issuing Certificate, 179 FERC ¶ 61,041 (Apr. 21, 2022) (“Certificate Order”).
2. *Tennessee Gas Pipeline Company, L.L.C.*, FERC Docket No. CP20-493-001, Notice of Denial of Rehearing by Operation of Law and Providing for Further Consideration, 179 FERC ¶ 62,152 (June 21, 2022) (“Rehearing Denial”).

This Court has jurisdiction over this Petition for Review pursuant to Section 717r of the Natural Gas Act, 15 U.S.C. § 717r, and the Administrative Procedure Act, 5 U.S.C. § 554. Petitioner intervened and participated in the certificate proceeding before the Commission,¹ and Petitioner filed a timely Request for Rehearing of the Commission order granting certificate on May 21, 2022.²

On June 21, 2022, the Commission denied Petitioner's rehearing request, thus rendering the Certificate Order final for judicial review under 15 U.S.C. § 717r(a). This Petition for Review is timely filed within sixty days of the Commission's order on rehearing. *See* 15 U.S.C. §717r(b).

Petitioner is a non-profit environmental protection organization whose mission includes advocating against new fossil fuel infrastructure and for strong action to prevent the worst effects of climate change, and Petitioner and its members are directly aggrieved by the Commission's orders approving the Project. *See* Declarations of Jo Ann Doran, Mitch Jones, Kristy Kasserman, Jeffrey Keida, Kelly Kessler, Megan McDonough, and Natalie Polvere in Support of Petitioner's Standing (Attachment 1).

This Petition raises several challenges to the Commission's approval of the Project, including that the Commission arbitrarily and capriciously departed from

this Court’s precedent in *Sierra Club v. FERC*, 867 F.3d 1357 (D.C. Cir. 2017) and *Food & Water Watch v. FERC*, 28 F.4th 277 (D.C. Cir. 2022), which ruled that the National Environmental Policy Act (“NEPA”) requires FERC to meaningfully evaluate the reasonably foreseeable indirect air pollution and greenhouse gas emissions from fossil fuel production and transportation projects.

Moreover, when assessing whether the project was required by the public convenience and necessity under the Natural Gas Act, the Commission’s orders neglected to consider whether this project would comply with the drastic emissions reduction requirements of the New York Climate Leadership and Community Protection Act, N.Y. ENVT’L LAW Ch. 43-B, § 75-0101, *et seq.*, which significantly impacts the analysis of project necessity that the Commission relied upon to approve this project.

Accordingly, Food & Water Watch petitions this Court to set aside the Commission’s orders on review, compel the Commission to comply with this Court’s ruling, and grant such other relief as may be appropriate.

DECLARATION OF JO ANN DORAN

1. My name is Jo Ann Doran. I am over the age of 18, competent to testify, and have personal knowledge of the facts set forth in this Declaration. Under penalty of perjury, I declare the following:
2. I am a current member of Food & Water Watch (“FWW”). I joined FWW because I support FWW’s advocacy efforts to stop the practice of hydraulic fracturing in the Marcellus and Utica shales and to ensure clean air for our communities.
3. In May 2022, Food & Water Watch filed a Request for Rehearing of the Federal Energy Regulatory Commission (“FERC”) decision granting Tennessee Gas Pipeline (“TGP”) a Certificate of Public Convenience and Necessity. This Rehearing Request was denied by FERC on June 21, 2022.

4. I reside at 786 Burnt Meadow Road, Hewitt, New Jersey 07421 and I have resided here for 48 years. Our home is located roughly 2,000 feet from the proposed construction site for TGP Compressor Station 327, which is one part of the East 300 upgrade project.

5. The East 300 upgrade project will directly harm me and my property. The proposed construction will include additional gas pipelines and the construction of TGP's new Compressor Station 327 in Passaic County, New Jersey. Since I live near the proposed construction site, I am very concerned that this will result in greater noise, air, and water pollution, as well as blowdown events and potential gas leakage, thus potentially harming my health. Because FERC did not fully analyze the pollution impacts of the project, I am in the dark about what I may be exposed to. As a result, if this compressor station is completed, I would be forced to keep my windows closed, even in clear weather, due to my concerns about breathing increased levels of harmful air pollution and the respiratory health ailments it could cause. I also will feel compelled to limit my time recreating and entertaining guests outside my home to limit my exposure to air pollution. I am further concerned that the project could harm the financial value and peaceful enjoyment of my property, as well as pose explosion risks.

6. Additionally, I am concerned about the increasing threat of climate change and its impacts resulting from expanded gas infrastructure, like the East 300

project, and the lock-in effect this project will have on future fossil fuel reliance. This continued reliance will have a tremendous effect on the changing climate of New Jersey. I will be directly impacted by the increasing severity of the region's storms, which I understand are predicted to become more frequent and more intense as a result of climate change, resulting in greater storm damage than when I moved to this residence 48 years ago. I am particularly concerned about harm to myself and my property due to damage that could result from severe flooding of the Wanaque River and Monksville Reservoir, which is located roughly 1,000 feet from my residence.

7. Having FERC's Certificate Order for the East 300 upgrade project vacated or remanded would protect my interests, as it would prevent the increase of localized air pollution that would result from this project. In so doing, it would allow me to continue to leave the windows open in my home during clear weather and recreate in the immediate vicinity of my home without the threat of shortness of breath or headaches from methane leakage and air pollution reported by many living near compressor stations. It would also ensure that the quiet enjoyment of my property that I still have would be maintained, as compressor stations are exceedingly loud during operation. Moreover, it would enforce FERC's requirement to analyze future emissions, air pollution, and comply with state

climate laws when reviewing gas infrastructure within the United States, the world's largest natural gas producer.

28 U.S.C. § 1746 DECLARATION OF MITCH JONES
IN SUPPORT OF STANDING

I, Mitch Jones, declare that I am over 18 years of age and competent to testify.
Unless otherwise stated, I have personal knowledge of the facts stated below and,
under penalty of perjury, declare as follows:

1. I am the Managing Director of Advocacy Programs and Policy at Food & Water Watch (“FWW”). I have worked for FWW for the past 13 years, and have held several positions within the Water, Fish, Common Resources, Climate & Energy, and Policy departments of FWW. Given my past and present duties, I am intimately familiar with the organization’s mission, membership, activities, and operations. My business address is 1616 P St. NW, Suite 300, Washington, D.C. 20036.

2. I make this declaration in support of FWW's standing in the above captioned case challenging the Federal Energy Regulatory Commission's issuance of a certificate of public convenience and necessity for the East 300 upgrade project.

FWW opposes the Commission's failure to consider indirect downstream air pollution, failure to analyze foreseeable indirect upstream impacts, and failure to consider this project's compliance with emissions reduction requirements mandated under New York's Climate Leadership and Community Protection Act.

3. FWW is a national non-profit membership organization with its headquarters in Washington, D.C. and staff that operate in California, Florida, Iowa, Maryland, New York, New Jersey, Oregon, and Pennsylvania. We have more than 280,000 members and supporters. Our organization's mission is to create a healthy future for all people and generations to come—a world where everyone has food they can trust, clean drinking water and a livable climate. FWW uses grassroots organizing, policy advocacy, research, communications, and litigation to further this mission.

4. Advocating for the rapid and just transition of our energy system to one that protects the environment, preserves clean water, and prevents the worst impacts of climate change is central to FWW's mission. Integral to this purpose is working to counter the many harms of our current energy system, prevent the expansion of unnecessary fossil fuel infrastructure, and promote cleaner and more equitable systems of energy production. To advance this goal, FWW dedicates significant

resources to developing and implementing campaigns to reduce pollution from fossil fuel extraction, transmission, and combustion. FWW conducts all of our advocacy work on behalf of our members and supporters, as well as the public.

5. FWW has a long history of work opposing extreme forms of energy extraction, like hydraulic fracturing (fracking) for oil and gas. FWW has spent much of the past 15 years campaigning to hold the federal government accountable for its failures to adequately protect public health from fracking, mitigate climate change, or regulate fossil fuel interests, and was the first nationwide organization to call for a ban on fracking.

6. FWW believes that it is vitally important that the federal government act to protect our environment and communities from the harm of pollution from oil and gas extraction, refining, transmission, and combustion. FWW closely tracks the leading research on fracking, other fossil fuel extraction, and climate change, and understands that it clearly shows that continued exploitation of fossil fuels will result in serious destruction of our lands, waters, air, and wildlife, which increases the risks of disease pandemics, crop failure, human conflict, and climate change-induced disasters. Air pollution from upstream extraction and downstream combustion also impacts communities' quality of life, public health, and air quality across the country. Methane leakage and combustion emissions contain hundreds of gases and compounds, including several chemicals regulated as hazardous air

pollutants under Section 112 of the Clean Air Act. The gas extraction process also involves many stages and provides many opportunities for the release of air pollutants.

7. One of our organizational goals is to educate our members and the general public regarding the impacts of pollution from oil and gas extraction, transmission, combustion, and wastewater disposal, as well as the impacts that this pollution has on climate change. To that end, we maintain a website and communications network whereby we keep our members, policymakers, media, and the public informed about the current model of oil and gas production in the United States, including the operation of fracking rigs and construction of new fossil fuel transmission, export, and combustion infrastructure.

8. To help fill gaps in public access to information about the harms of the oil and gas industry, FWW regularly drafts data-driven policy reports, white papers, fact sheets, and web pieces about the health and environmental impacts of oil and gas extraction, as well as methods for transitioning to non-fossil fuel sources of energy. FWW's recent publications include a February 2022 report "Averting Climate Catastrophe: Fossil Fuels Must End While Renewables Take Over," a February 2021 fact sheet "Dangerously Deep: Fracking's Threat to Human Health," a February 2021 issue brief "Now We're Fracked: Fracking's Public Health Crisis," a January 2020 report "Fracking's Bridge to Climate Chaos," a

detailed June 2019 report “The Fracking Endgame: Locked Into Plastics, Pollution and Climate Chaos,” an October 2019 fact sheet “Fracking Wastewater: A Toxic and Radioactive Problem,” and a June 2020 fact sheet “Drilled Too Far: The Perils of Injection Wells.”

9. FWW advocates extensively for the cessation of fossil fuel extraction due to its impacts on local communities and the global climate. This has included: campaigning in support of hydraulic fracking bans; campaigning in support of state and local energy transition resolutions; and petitioning governmental agencies for stricter controls on extraction, transmission, and use of fossil fuels, including controlling emissions of greenhouse gases released via fossil fuel infrastructure. FWW has successfully campaigned for fracking bans in Maryland, New York, and the Delaware River Basin, as well as a fracking pause in Oregon and municipal bans across the nation.

10. We believe that, to date, the Federal Energy Regulatory Commission has failed to adequately regulate the gas transmission industry by considering projects’ full range of harmful effects, including the downstream air pollution that the industry brings, the upstream impacts from gas extraction, and hindering states’ abilities to meet state law climate emission mandates. The Commission’s inadequate reviews enable harmful fossil fuel projects to advance, exacerbating climate change and directly undermining FWW’s mission. FWW has also spent

and continues to expend significant organizational resources engaging in the Commission's fossil fuel project approvals, including by organizing public opposition, commenting on draft and final environmental reviews, and challenging certificates in federal court.

11. The Commission's failure to consider all relevant project impacts when approving the East 300 upgrade project similarly harms FWW, as well as its many members who live in New York, New Jersey, and Pennsylvania. FWW and our members have a strong interest in vacating the Commission's certification of the East 300 project due to air quality and public health benefits that will result from its vacatur. In the alternative, remand would also redress FWW's injuries, though to a lesser degree, as it would require the Commission perform a more robust environmental review that would improve FWW's advocacy efforts and better inform FWW's members about risks to which they may be exposed.

12. As an organization that partners with community groups and frontline residents to mitigate the harms of oil and gas extraction and works to inform the public about pollution from oil and gas operations, FWW and our members and supporters would be directly and adversely impacted by the Commission deficient environmental review of this project and the ultimate construction of this infrastructure. The project threatens to further expose FWW members to hazardous environmental and public health effects stemming from widespread extraction in

northeastern Pennsylvania. FWW would have to continue dedicating resources to advocacy before the Federal Energy Regulatory Commission that it could otherwise dedicate to other climate change work.

13. FWW believes that the United States will not be able to address climate change without thorough consideration of fossil fuel projects' impacts. A court order requiring the Federal Energy Regulatory Commission to engage in meaningful consideration of the climate and public health impacts of oil and gas extraction, transmission, and combustion, as required under the National Environmental Policy Act, would greatly benefit our work and promote FWW's goals and mission. A thorough review of indirect effects of the project, as well as compliance with state law emissions reduction requirements, is critical to sound decision-making and necessary to prevent further harms to our members, whose health, quality of life, and recreational and aesthetic interests will be adversely affected by the fossil fuel extraction, transmissions, and combustion associated with the East 300 upgrade project. FWW would use the additional information provided by review of these concerns by Federal Energy Regulatory Commission to advocate for denial of certificates for similar proposals, stronger regulation of dangerous air pollutants, strong federal policies to slow climate change, and to otherwise help address the suffering that our members living on the fence lines of gas operations are forced to endure.

DECLARATION OF KRISTY KASSERMAN

1. My name is Kristy Kasserman. I am over the age of 18, competent to testify, and have personal knowledge of the facts set forth in this Declaration.

Under penalty of perjury, I declare the following:

2. I am a current member of Food & Water Watch (“FWW”), as well as the Factory Farm Organizing Director for FWW. I joined FWW because of FWW’s dedication to stopping the expansion of fracking and the organization’s early call for a ban on fracking for natural gas.

3. I reside at 201 Estate Road, Atkinson, North Carolina and my family and I have resided here for five years. Prior to living in this residence, I lived in Somerset County, Pennsylvania and where I had lived for 13 years.

4. I moved from Pennsylvania in December 2017, partly due to the increased ubiquity of shale drilling and hydraulic fracturing in the area, which was spawned by the completion of several large-scale gas transmission pipelines which increased the market transportation capacity needed to move gas out of the Marcellus and Utica shales. While living in Pennsylvania, I regularly (multiple times per week) engaged in outdoor recreation activities that were impacted or had the potential to be impacted by the expansion of fracking. These activities included mountain biking, road biking, cross country and downhill skiing, trail running and hiking, whitewater kayaking, and swimming. The expansion of natural gas infrastructure into the area where I lived impacted some of these activities significantly, including increased polluting runoff from pipeline and well pad construction, increased heavy truck traffic, and disruption or loss of access to areas that I had previously used for recreational opportunities.

5. I continue to visit western Pennsylvania regularly in part to see family and friends who still live there and in part to engage in the outdoor recreational activities described above. Many of these activities are not available to me where I currently live, and Somerset, Fayette, and Westmoreland Counties continue to be among my favorite places to road bike, mountain bike, trail run, and paddle. However, drilling and hydraulic fracturing to feed pipelines, and the resulting

increase in air and water pollution within my former community, diminished my enjoyment of the recreational activities I continue to engage in when I visit.

6. I am aware that in May 2022, Food & Water Watch filed a Request for Rehearing of the Federal Energy Regulatory Commission (“FERC”) decision granting Tennessee Gas Pipeline (“TGP”) a Certificate of Public Convenience and Necessity, on behalf of itself and members like myself. I am also aware that FERC denied this Rehearing Request on June 21, 2022.

7. As a result of my work with FWW and my own interest in keeping up on oil and gas issues in Pennsylvania, I am aware that due to the proposed increase in capacity of TGP’s East 300 line and the increase in contracted daily gas volumes for Consolidated Edison, additional upstream extraction of methane gas will be necessary. In order to provide the additional gas supply, additional well drilling and hydraulic fracturing will be required within the Marcellus and Utica shales of Pennsylvania. I am concerned that, despite this foreseeable result of FERC’s approval, the Commission failed to consider the upstream impacts of approving the East 300 project, leaving me and upstream community members in the dark on the full extent of this project’s indirect effects.

8. I will be directly impacted by this project’s indirect upstream impacts caused by increased gas drilling and hydraulic fracturing. I continue to regularly visit and recreate in Somerset, Fayette, and Westmoreland counties in Pennsylvania; I

intend to visit this fall, 2022, to ride my mountain and road bikes and to canoe. If this project were to be completed, I would be forced to reconsider the activities that I engage in while visiting, and would certainly enjoy many of these activities less due to the increased risk from heavy truck traffic and the likelihood of increased air and water pollution caused by additional gas drilling and hydraulic fracturing in the Marcellus and Utica shales spurred by this project.

9. My concerns would be addressed if FERC's Certificate Order for the East 300 upgrade project were to be vacated or remanded. A Court order finding FERC's analysis was inadequate would require FERC to provide robust analysis of how this project's requirement of increased upstream drilling would impact my recreational pastimes within the Marcellus and Utica shale region and would allow for impacted members of the public, like myself, to meaningfully engage with the Commission during review of the project. With more information about the upstream drilling plans needed for the project, I would be able to decide what activities to engage in and in what locations, without concern of exposure to increased traffic and pollution, and would be able to enjoy these activities more. An Order vacating the approval would also allow me to continue to engage in the outdoor recreational opportunities that I enjoy including mountain biking, road biking, cross country and downhill skiing, trail running and hiking, whitewater

kayaking and swimming without worrying about potential impacts from expanded shale gas drilling.

DECLARATION OF JEFFREY KEIDA

1. My name is Jeffrey Keida. I am over the age of 18, competent to testify and have personal knowledge of the facts set forth in this Declaration. Under penalty of perjury, I declare the following:
2. I reside at 35 Brown Rd., Wantage, New Jersey 07461 and I have resided here for four years. Our home is located about roughly 3,000 feet from the proposed expansion site of Compressor Station 325, which is owned and operated by Tennessee Gas Pipeline Company (“TGP”).
3. I am a current member of Food & Water Watch (“FWW”). I joined FWW because I am concerned about the both the immediate and long-term impacts caused by the expansion of fossil gas infrastructure throughout New Jersey and the United States more broadly.

4. I have personally opposed construction of pipelines, fracking, and compressor stations through protesting of the new construction in West Milford, New Jersey, protesting and commenting at the public hearing for Department of Environmental Protection air permits in Sparta, New Jersey, writing letters to Governor Murphy and the Department of Environmental Protection opposing the expansion of the site in Wantage and the new construction in West Milford.

5. Due to the proposed increase in capacity and construction activity, TGP's compressor station and pipeline project directly impact myself and my property.

6. The proposed construction of additional fossil gas pipeline capacity and the expansion of TGP's Compressor Station 325 will result in greater noise, air, and water pollution, thus severely affecting the financial value, peaceful enjoyment, and aesthetic value of my property. I have been impacted and will continue to be impacted by this project due to increased noise, air, and water pollution that will harm the health of my wife, children, and myself resulting from gas-powered compressor emissions and more frequent and intense blowdown events.

Completion of this project would also increase my anxiety of explosions and fuel growing concern for the climate change impacts resulting from expanded fossil gas infrastructure.

7. On January 1st, 2022, there was an unplanned blowdown at Compressor Station 325 that lasted 70 minutes. The noise pollution was so loud that we thought

a jet was hovering over our house, but we eventually realized it was the compressor station. We were afraid to go outside as the smell of the noxious gas concerned us about potential health risks. This blowdown event has made us afraid to live next to the compressor station, we continue to be afraid of it, and would be further harmed if the compressor station were to be expanded. Hearing the station on a regular basis puts us in a constant state of anxiety and fear about the safety of air that we, and our children, are breathing. As a result of the blowdown and fugitive emissions from existing gas infrastructure, I have experienced severe headaches which stand to worsen if this project were to be completed. I have also been concerned about opening my windows and allowing my children to play outside of our home as a result of emissions from Compressor Station 325. Both the increased regularity and intensity of these blowdown events will result in exacerbated health issues if the expanded compressor station and installation of additional pipeline infrastructure are completed in the area.

8. Additionally, completion of this project exacerbates my growing concern related to climate change impacts resulting from expanded fossil gas infrastructure and the continued reliance upon fossil fuels. I am particularly concerned about the emissions of greenhouse gases that will come from this proposed facility and add to the accumulation of greenhouse gases in the atmosphere, resulting in a changing climate for New Jersey. I will be directly impacted by the region's worsening

storms, which are predicted to become more frequent and more intense as a result of climate change; this will result in direct harm to myself and my property due to potential damage that will result from severe flooding of the stream that runs directly through our property, then flows into the Clove Brook, the Clove Acres Lake, and then into the major the Wallkill River – which are all major local fishing waters.

9. I have had to spend \$3,000.00 for New Jersey Department of Environmental Protection permits to place our house 250 feet away from the stream that runs through our property, which is considered a Class A exceptional stream because of its size and the animals that live in and use the stream. I am extremely concerned that TGP is attempting to expand its major polluting facility next to such exceptional waterways and I would be impacted by the potential of this project to harm our stream and the high-quality waterways in the vicinity of my home.


10. Having FERC's Certificate Order for the East 300 project set aside would allow my family to continue to leave the windows of my home open during nice weather, enjoy the outdoor spaces in the immediate vicinity of my home, and would ensure the quiet enjoyment of my property while protecting my health from further amplified emissions-induced problems like severe headaches. Moreover, it would enforce FERC's requirement to analyze emissions and climate change impacts within its review of gas infrastructure permitted within the United States,

the world's largest natural gas producer, providing me with more information about what the project's potential impacts will be.

11. In May 2022, Food & Water Watch filed a Request for Rehearing of the Federal Energy Regulatory Commission ("FERC") decision granting TGP a Certificate of Public Convenience and Necessity. This Rehearing Request was denied by FERC on June 21, 2020. As a member of Food & Water Watch, the rehearing request plainly states that it was filed on our behalf.

12. Pursuant to the provisions of 28 U.S.C. § 1746, I declare, under penalty of perjury of the laws of Massachusetts, that the foregoing Declaration is true and accurate to the best of my knowledge.

DECLARATION OF KELLY KESSLER

1. My name is Kelly Kessler. I am over the age of 18, competent to testify, and have personal knowledge of the facts set forth in this Declaration. Under penalty of perjury, I declare the following:
2. I am a current member of Food & Water Watch (“FWW”). I joined FWW because I consider myself quite active on a whole host of issues, including environmental and climate change issues central to FWW’s mission. I share FWW’s goals, particularly its aims to guarantee a habitable climate for future generations through ending reliance on fossil fuels and ensuring clean air for our communities. I have personally opposed construction of pipelines, fracking, and compressor stations through sending letters to the governor of New Jersey, signing petitions, and engaging in community activism.

3. I reside at 35 Brown Road, Wantage, New Jersey 07461 and my family and I have resided here for 3 years. Our home is located approximately 3,000 feet from the proposed expansion site of Compressor Station 325, which is owned and operated by Tennessee Gas Pipeline Company ("TGP") as part of the East 300 upgrade project.

4. I am aware that in May 2022, Food & Water Watch filed a Request for Rehearing of the Federal Energy Regulatory Commission ("FERC") decision granting TGP a Certificate of Public Convenience and Necessity, on behalf of itself and members like myself. I am also aware that FERC denied this Rehearing Request on June 21, 2022.

5. Due to the proposed increase in capacity and construction activity, TGP's compressor station and East 300 pipeline project will directly impact me and my property.

6. I am very concerned that the proposed construction of additional fossil gas pipelines and the expansion of TGP's Compressor Station 325, authorized by the Federal Energy Regulatory Commission certificate at issue in this action, will result in greater noise, air, and water pollution, thus severely affecting the financial value and peaceful enjoyment of my property. I have already been adversely impacted by this compressor station and believe I will be even more impacted by

this project due to increased noise, health issues resulting from gas-powered compressor emissions and larger and more frequent blowdown events (where methane gas is vented into the community due to pressure regulation issues at the compressor unit), increased anxiety of explosions, and growing concern for the climate change impacts resulting from expanded fossil gas infrastructure.

7. I am concerned that FERC did not fully consider the air pollution impacts and climate impacts of the East 300 project, and that I did not have the information I need to fully engage in its process and advocate against the project's approval.

8. As a result of blowdown and air emissions from existing gas infrastructure, I have experienced the noxious smell of gases and sound levels that have at times made it unpleasant to leave my home. I have been forced to limit the use of my outdoor space due to local air pollution and I will be further limited if this project is completed, because the increased capacity will lead to increased emissions.

9. I am also genuinely fearful of the impacts the compromised air quality will have on my own and my family's health. With increased compression capacity on the existing line, the regularity and intensity of blowdown events will be increased. My family and I already experience harmful health effects that I believe are due to the compressor station and related pollution, including headaches. I am concerned that the project will exacerbate these health impacts. I have a three-year-old son and I am currently pregnant with my second child; as a result of this project, I will

be forced to further restrict my children's outdoor time due to the increase in local air pollution from the compressor station. I live in a rural area to minimize exposure to pollutants and prevent harmful ailments; this project would frustrate that as it has the potential to be very damaging to my family's health.

10. Additionally, I am concerned about the value of my property being significantly diminished by this project. The noise, pollution, and blowdown events associated with the compressor station, which will worsen with the increased compression on existing lines due to this proposed expansion, will make my property less enjoyable and desirable. This expansion would negatively impact my ability to sell my property in the future and I am very concerned about the potential monetary harm to myself and my family.

11. Completion of this project also exacerbates my growing concern related to climate change impacts resulting from expanded fossil gas infrastructure and the United States' continued reliance upon fossil fuels. I am particularly concerned about the emissions of greenhouse gases that will come from this proposed facility, which will add to the accumulation of greenhouse gases in the atmosphere, resulting in a changing climate for New Jersey. I will be directly impacted by the region's strongest storms, which are predicted to become more frequent and more intense as a result of climate change, delivering significantly more precipitation and resulting in more flooding due to rain coming in large bursts instead of in

staggered, manageable amounts. Climate change will result in direct harm to myself and my property due to the potential damage that will result from severe storms.

12. Having FERC's Certificate Order for the East 300 upgrade project vacated or remanded would substantially address my concerns. It would allow me to continue to leave the windows open in my home during clear weather, allow my children to play in the immediate vicinity of my home, and would ensure the quiet enjoyment of my property would not be further diminished, while protecting my health from a further increase in hazardous emissions. A court order affirming FERC's requirement to fully analyze emissions and climate change impacts in its review of gas infrastructure would also lessen my injuries, by requiring FERC to more carefully consider the pollution and climate impacts the upgrade project would have on my community, providing me with information I need to inform myself and my family's choices and better enable me to take precautions to protect our health and finances.

DECLARATION OF MEGAN MCDONOUGH

1. My name is Megan McDonough, I am over the age of 18, competent to testify, and have personal knowledge of the facts set forth in this Declaration.

Under penalty of perjury, I declare the following:

2. I am a current member of Food & Water Watch (“FWW”) as well as the Pennsylvania Organizing Director for FWW. I became involved with FWW four years ago so as to challenge the expansion of hydraulic fracturing for methane gas in the Marcellus and Utica shales in Pennsylvania, as this practice threatened, and continues to threaten, my and my family’s health and well-being.

3. I reside at 100 White Hampton Lane, Pittsburgh, Pennsylvania and I have resided here for two years. I am a lifelong resident of Allegheny County, Pennsylvania. Before moving to my current home, I lived in a frontline community impacted by hydraulic fracturing for the last fourteen years. I still own that home.

4. I am aware that on May 2022, Food & Water Watch filed a Request for Rehearing of the Federal Energy Regulatory Commission (“FERC”) decision granting Tennessee Gas Pipeline (“TGP”) a Certificate of Public Convenience and Necessity, which FERC denied on June 21, 2022.

5. I am concerned about the upstream gas extraction that will be required by the expanded gas transmission infrastructure capacity of the East 300 project. TGP’s East 300 project will harm me and my community due to the proposed project’s expansion of gas transmission capacity, which would require additional gas extraction in order to provide Consolidated Edison with the increased volume of gas for which it has contracted with TGP. Due to my research into the FERC approval process for the project, I am aware that in order to provide this gas to Consolidated Edison, upstream Marcellus and Utica shale gas extractors will be required to perform additional well drilling and hydraulic fracturing to provide those contracted volumes of gas over the multi-decadal lifespan of this infrastructure. I am concerned that this drilling is likely to occur within my community, as Allegheny County, Pennsylvania is already home to extensive gas extraction and hydraulic fracturing operations that supply gas to most of the east coast. Moreover, the existing 300 line operated by TGP, which will be expanded by this project, already provides gas primarily from this region. These extraction operations are expected to continue and expand in the event that transmission

capacity is expanded. I am also aware that FERC failed to consider the impacts of this “upstream” extraction activity as part of its required environmental review of the project under the National Environmental Policy Act, and has failed to request information about exactly where this extraction will take place. As a result of this failure, I have been left with inadequate information to engage in the FERC public participation process for the project in an informed manner.

6. FERC’s failure to require information about and carefully review the impacts of upstream extraction also leaves me without important information about potential harmful impacts I and my family may be exposed to as a result of the project. Given where hydraulic fracturing for the 300 line already takes place, it is very likely that completion of this project, and the subsequent expanded gas extraction operations required to supply it, would result in direct harm to my and my children’s health and well-being due to increased air, water, and noise pollution in the Marcellus and Utica shale play, which includes the area surrounding my home in Allegheny County, Pennsylvania. Due to my citizen activism, research, and my work with FWW, I am aware that hydraulic fracturing and the air pollution it causes are associated with a range of harmful health effects, such as headaches, nosebleeds, nausea, and respiratory ailments. These effects are common for residents near oil and gas wells and hydraulic fracturing operations.

7. I engage in many outdoor activities in my community, such as regular walks in Round Hill Park, fishing and recreating with my children near and in the Youghiogheny River, and regular walks on the Great Allegheny Passage. All of these locations face the threat of expanded extraction operations in the event that this project is completed. As a result, increased drilling in my area would make me reluctant to continue engaging in these activities with my children, particularly on days when the air quality is poor. Knowing that drilling activity is contributing to noise, air, and water pollution already lessens my enjoyment of these activities. Increased drilling will deepen these concerns and further diminish my ability to enjoy spending time with my family outdoors.

8. Moreover, expanded drilling and installation of gathering lines connected to well pads will increase my anxiety of explosions in my community, as numerous gas extraction and transportation explosions have occurred within my area. This concern will make it yet harder to enjoy spending time outdoors with my family, as I will increasingly fear for their and my own safety.

9. Lastly, I am concerned that the project will harm me financially, due to the impact that expanded gas extraction operations would have on the market value of my home.

10. Having FERC's Certificate Order for the East 300 upgrade project vacated or remanded for further review of upstream impacts would help prevent further

degradation of local air quality in my community and would protect my and my family's health from air pollution-induced health problems like headaches, nausea, nosebleeds, and respiratory ailments. This would make me feel safer continuing to enjoy the outdoor activities my family and I regularly engage in. Furthermore, requiring FERC to gather information about the project's drilling and extraction plans and locations and perform an environmental review of the upstream impacts of expanding gas transmission capacity would also allow me and other community members to know the extent to which this project will directly affect us and better engage in the public participation process.

DECLARATION OF NATALIE POLVERE

1. My name is Natalie Polvere, I am over the age of 18, competent to testify, and have personal knowledge of the facts set forth in this Declaration. Under penalty of perjury, I declare the following:

2. I am a current member of Food & Water Watch (“FWW”). I became a member nearly four years ago so as to join in the organization’s advocacy against New York state’s continued reliance upon fossil fuels and to protect regional air quality in Westchester County. FWW’s advocacy before the Federal Energy Regulatory Commission also represents my interests in curtailing further fossil fuel usage in New York.

3. I have been very actively engaged in climate activism since spring 2018 and have specifically volunteered to challenge fossil fuel infrastructure with Food & Water Watch since early 2019. I have traveled to Albany with FWW organizers to

lobby our legislators and I have helped organize rallies here in Yonkers, at the office of our state Senate Majority Leader. I have rallied, written letters, and testified at public hearings to prevent renewal of Title V air permits and the expansion of old fossil gas power plants in New York.

4. Among the most important bills I have worked with Food & Water Watch on is the “All Electric Building Act,” and the New York State Senate included the language of the bill in its budget this spring. This legislation would mandate that, after December 31, 2023, new construction of any structure up to six stories tall will be prohibited from having fossil fuel infrastructure, with a ban on fossil fuel infrastructure on structures that are taller than six stories going into effect in 2027.

It follows the example of New York City, which has recently passed such a bill.

Unfortunately, the Assembly did not include the bill in its budget this session.

Based on my research and advocacy, I believe legislation like this is vital to meeting the mandates of New York’s Climate Leadership and Community Protection Act. When and if enacted, it is my understanding that this bill or similar legislation would likely impose prohibitions on new gas connections in the state during the useful life of the East 300 project’s upgraded infrastructure.

5. I reside at 41 Grand View Blvd., Yonkers, New York 10710 and I have resided here for 33 years. I am a customer of Consolidated Edison (“ConEd”), the

local distribution company in Westchester County that will receive gas from the East 300 upgrade project's construction.

6. I am aware that on May 2022, Food & Water Watch filed a Request for Rehearing of the Federal Energy Regulatory Commission ("FERC") decision granting Tennessee Gas Pipeline ("TGP") a Certificate of Public Convenience and Necessity, which FERC denied on June 21, 2022.

7. Due to the proposed increase in capacity and construction activity, TGP's East 300 project will harm me and my community in several ways.

The proposed construction of additional fossil gas pipelines and the expansion of TGP's East 300 compressor stations will result in greater air pollution in and around ConEd's downstream distribution network in Westchester County, New York, potentially affecting not only my own health and recreation, but also the financial value and peaceful enjoyment of my property due to ongoing degraded air quality in the County. I am already impacted regularly by the county's poor air quality, as the New York State Department of Environmental Conservation issues frequent air quality alerts for the area which force me to stay indoors or limit outdoor activities on a number of days of the year. Specifically, I know that Westchester County, New York is already in noncompliance with the Clean Air Act's national ambient air quality standards for ozone, which is a byproduct of methane gas. Further, my house is situated between heavily-trafficked Central Park

Avenue, which is about 1,000 feet to the west, and the Bronx River Parkway, about 2,000 feet to the east, contributing to the already degraded local air quality. I will be impacted by this project because it will cause an increase in this already dangerous air pollution, which I am concerned would impact my health and lead to headaches and other respiratory ailments caused by chronic degraded air quality. An increase in air pollution in Westchester County would result in more and worse air quality alert days and would force me to spend less time outdoors and walking in my neighborhood and area parks. As I regularly enjoy walking through my neighborhood, such air pollution would greatly diminish my enjoyment of my property and nearby parks.

8. Additionally, if this project were to be completed, it would lock-in fossil fuel reliance in Westchester County for decades to come; this would worsen my growing anxieties related to climate change impacts. I am particularly concerned about the additional emissions of greenhouse gases that will come from this proposed project, adding to the accumulation of greenhouse gases in the atmosphere and resulting in a changing climate for New York.

9. I will be directly impacted by the increasing intensity and frequency region's strongest storms, which have been increasing in frequency and severity over the last decade as a result of climate change, delivering significantly more precipitation than when I moved to this residence over thirty years ago. This is

resulting in greater local flooding as rain events are beginning to arrive in large downbursts instead of in staggered, manageable amounts; as a result, I have recently experienced water leakage into my basement and my neighbors have seen significant flooding of their basements. Climate change will also lead me to further lessen my ongoing and regular use and enjoyment of community parks near my residence due to the likelihood of flooding of the Bronx River, roughly 2,500 feet from my residence. I will also be impacted by the increased flooding of the Bronx River Parkway, a road that I rely upon to enter and leave my neighborhood. Lately it has been regularly closed as a result of heavy rainfall events, and will see more frequent flooding events resulting in more closures as a result of climate change.

10. Further, the Commission's failure to consider downstream air pollution impacts of this project has left myself and others in my community unable to meaningfully assess the true local impacts of this project. As a result, I have been limited in how I can meaningfully engage with the Commission in an informed manner during the project review period.

11. Last, I am concerned that the project will harm me financially, due to the likely pass-through of costs from ConEd to ratepayers like myself in the event of stranded assets from the East 300 upgrade. If this project is completed and then forced to go offline before the end of the infrastructure's useful life, due to emissions reduction requirements and gas hookup moratoria under New York law,

then I will likely face rate increases for any TGP stranded assets installed as part of the East 300 project. As such, the Commission's failure to consider the project's compliance with the requirements of New York's Climate Leadership and Community Protection Act directly impacts me.

12. Having FERC's Certificate Order for the East 300 upgrade project vacated or remanded for further downstream air pollution review would help allow me to leave my home without greater fear of dangerous air pollution, continue to recreate in the riverfront parks of my community, and would protect my health from potential air pollution induced problems like headaches and respiratory ailments that would result from additional gas combustion. It would also protect me from future rate increases due to the construction of potentially stranded assets as New York law requires emissions reductions over the useful life of this project. The Commission has provided no information on how residents of Westchester County would be impacted by the downstream air pollution caused by this project, nor has it addressed this project's compliance with New York law. As such, a determination from this Court that the Commission is required to analyze indirect emissions and air pollution, as well as project compliance with state laws, would provide detailed information to residents of Westchester County on how they would be affected by this project and provide residents, like myself, with the opportunity to engage in an informed manner with the Commission. It would also

benefit me by ensuring that FERC has to carefully consider the risks of stranded assets, making it less likely that I will face rate increases.
