- B. Permanently enjoining and setting aside the WOTUS Rule in its entirety;
- C. Awarding the Plaintiff States costs and attorneys' fees;
- D. Granting the Plaintiff States all additional relief as may be necessary and appropriate or as the Court deems just and proper.
