The Defendants, through their undersigned counsel, respectfully move this Court to stay this case for 90 days to allow additional time for new leadership at the Department of Justice and the client agency to familiarize themselves with this litigation and to review pleadings relevant to this case.

Pursuant to L.R. 3.01(g), counsel for Defendants consulted with counsel for Plaintiffs, who indicated that Plaintiffs do not oppose a 90-day stay.

Plaintiffs challenge DOL's 2023 Rulemaking, "Adverse Effect Wage Rate Methodology for the Temporary Employment of H-2A Nonimmigrants in Non-Range Occupations in the United States," 88 Fed. Reg. 12760 (Feb. 28, 2023). A preliminary injunction was entered against Defendants on September 18, 2024, and remains in place. ECF 46 & 61. A schedule was entered on February 5, 2025, which anticipates a Rule 26(f) report to the Court on March 26, 2025, with discovery thereafter and dispositive motions on December 22, 2025. ECF 63.

At this time, multiple appointed positions at the client agency have yet to be confirmed, including the Secretary of Labor, the Deputy Secretary of Labor, the Assistant Secretary of the Employment and Training Administration, and the Administrator of the Wage and Hour Division. As a result, more time is needed for the new administration to review this pending litigation.

Accordingly, Defendants respectfully request that this Court stay this litigation for 90 days.
