STIPULATION OF DISMISSAL

Pursuant to Federal Rule of Civil Procedure 41(a)(1)(A)(ii), the undersigned representing all parties who have appeared in this case stipulate to Plaintiffs' voluntary dismissal of the Amended Complaint (Dkt. 50) with prejudice.

Plaintiffs previously notified the Court of the United States District Court for the District of Arizona's Order vacating the 2020 registrations at issue in this case. *Ctr. for Biological Diversity v. U.S. EPA*, No. 4:20-cv-00555-DCB, 2024 WL 455047 (D. Ariz. Feb. 6, 2024) (Dkt. 85). The court's Order was not appealed, and the 2020 registrations remain vacated. Accordingly, the parties in this case have conferred and agreed to Plaintiffs' voluntary dismissal of the Amended Complaint. Each party shall bear its own costs and fees in this matter.
