Active Cases in the MDL

In the Coy's Honey Farm Inc. case (1:21-cv-00089), discovery has closed and there are no pending motions. Monsanto Company believes this case is now ready to be remanded to the transferor court for further proceedings.

A settlement has been reached in the Flamm Orchard case (4:18-cv-01849), and the parties are working on finalizing the settlement agreement.

The parties are not aware of any other cases in the MDL that are not otherwise addressed or covered by the Soybean Growers Settlement (discussed below).

Soybean Growers Settlement

All soybean settlement claims have been processed, and all that were approved have been paid. The last tranche of settlement payments were sent to claimants earlier this month. The parties expect to complete all remaining obligations set forth in the settlement within the next month.
